**C.A.R.R.E.: A Framework for Rural Health Equity**

This session introduces the C.A.R.R.E. Framework (Collaboration, Advocacy, Resource, Research, and Education), a storytelling-based approach that builds community capacity and advances health equity in rural communities. Participants will learn how An Insightful Journey (AIJ) centers community—especially those historically excluded from decision-making—to identify service gaps, co-create culturally relevant solutions, and strengthen cross-sector partnerships. Including practical strategies to improve access to healthcare services while addressing race, culture, social support networks, and other critical social determinants of health.

**Racism as a Public Health Emergency: Advancing Immigrant and Refugee Health by Addressing Underlying Social Drivers of Health.**

In Maine, immigrants face disproportionate barriers across the social determinants of health due to structural inequities embedded in healthcare and public policy. This session showcases MaineHealth's equity-centered approach leveraging SDOH screening, race/language-stratified data, cross-sector partnerships, and collaboration with policymakers to drive systems change

such as LD1080, a bill to remove income-based utility deposit requirements that disproportionately impact immigrants without credit history. Participants will learn how community-informed data and partnerships are advancing health equity.

Across rural communities, “Community Care Hubs” are an emerging way to bring together health care entities and community-based organizations to coordinate services and strengthen local networks. This session will share the results from nationwide key informant interviews and case studies showing how different communities have developed hubs in unique ways. Utilizing these national examples, attendees will learn practical integration strategies and explore inspiring cases of innovation and community-driven solutions in rural health care.

### **Leveraging Foodcare to Reduce Chronic Disease burdens and Ease Provider Strain**

Explore how medical nutrition therapy and food is medicine can be woven into routine care in rural communities to help providers prevent and manage chronic disease while easing clinic workload. Participants will see how payer, rural health clinic, and community food program partnerships use foodcare, telehealth, and digital tools to extend nutrition support, enable bi-directional referrals, and track outcomes that demonstrate better patient health and reduced provider strain.

**Elevating Rural Voices: Digital Storytelling with Community Health Workers and Rural Health Advocates**

This session explores how digital storytelling strengthens rural health access by elevating the lived experiences of Community Health Workers and rural health advocates. Participants will learn a practical process for guiding storytellers, creating ethical narratives, and using stories to build trust, support program development, and inform policy. We will share results from training sessions conducted with Community Health Workers across Iowa, demonstrating how digital storytelling increases engagement and visibility of rural health challenges and opportunities.

**Strengthening Rural Care Through CHW Workforce**

This session highlights how an accelerated Community Health Worker training model improves rural health access by addressing social determinants of health, care coordination, and chronic disease management. We will share outcomes from South Dakota's CHW workforce expansion, including a 61% contribution from one rural-serving college, and demonstrate how CHWs bridge gaps between clinical care and community needs. Practical strategies for rural replication and workforce pipeline development will be provided.

**Understanding Multimorbidity in Rural Communities**

Rural adults experience a disproportionate burden of cardiometabolic multimorbidity. Understanding multilevel risk and protective factors is necessary for prevention, intervention, and treatment of these conditions. Semi-structured interviews were conducted to understand the lived experiences of rural African American adults (N=24). This session highlights patterns in the onset, progression, and management of multiple cardiometabolic conditions and describes strategies for community-based interventions. Participants will learn how individual, interpersonal, and access challenges shape the experiences of rural adults.

**Diabetes Prevalence and Dialysis Care in Rural America**

Rural residents have a higher diabetes prevalence than urban residents. Furthermore, dialysis care is not as easily accessed in rural areas as in urban areas. This session explores the increased risk of diabetes in rural areas and potential solutions/barriers to addressing the disproportionate diabetes burden faced by rural residents. It will also examine how prevalence has changed over time in rural areas and which socioeconomic and demographic groups have the greatest prevalence in rural areas.

As rural areas face workforce shortages and other challenges to meeting their behavioral health needs, Alaska's Behavioral Health Aide (BHA) Program provides a model that has demonstrated success in delivering behavioral health services in rural and remote areas. This presentation describes findings from a statewide environmental scan of BHA practice throughout the Alaska Tribal Health System using self-report surveys with BHAs. Implications for implementing the BHA model in other rural and remote settings are discussed.

**Rural Maternal Care: The Next Shift**

Rural maternity care is in crisis, with over 100 rural hospitals discontinuing labor and delivery since 2020; and disproportionately affecting women of color, Indigenous populations, frontier communities, and low-income rural families. This session examines the national landscape and operational challenges driving these closures, and how new CMS and ACHC maternal health standards, including emergency readiness requirements, can guide hospitals in redesigning

care, advancing equity, improving outcomes, and sustaining safe, local access to essential obstetric services.

Rural older adults are often overlooked in California policy, despite rapid population growth and facing workforce shortages, housing insecurity, and health disparities. Funded by The SCAN Foundation, the University of California, Davis and three regional coalitions developed policy briefs on housing, long-term services and supports, and health care access grounded in community and provider perspectives. This session shares key findings, state policy recommendations, and strategies to advance rural aging equity and strengthen cross-sector advocacy.

**Kansas CARES- A statewide community health worker model**

This 75-minute presentation will offer a deep dive into the Kansas CARES (Coordinating and Assisting Reliable Enrollment Services) Program's model for sustainable rural health equity. We'll cover the Community Health Worker (CHW)-driven strategy for reducing uncompensated care and improving outcomes, the plan to stabilize funding through policy advocacy (CHW Medicaid reimbursement), and the vital role of technology and strategic partnerships required in securing the financial future of rural healthcare.

**Building Effective Partnerships with Promotores de Salud to Strengthen Cancer Support in Hispanic Communities**

This session highlights best practices for partnering with Promotores and Community Health Workers to better support underserved Hispanic populations affected by cancer. The presenter will share lessons from grassroots collaborations, culturally responsive engagement strategies, and evidence-informed approaches to addressing persistent barriers to care. Participants will gain practical tools to strengthen trust, improve access to reliable cancer information, and enhance support for rural Hispanic patients and families across the cancer continuum.

#### **Breaking Barriers: Teleneurology for Rural Veterans' Neurological Care Gaslamp CD**

Rural Americans face inequities in access to neurological expertise due to workforce shortages and geographic barriers, resulting in delayed diagnoses and poorer outcomes. The Veterans Health Administration addresses barriers through teleneurology solutions. This session showcases how the Veterans Health Administration leverages telehealth, closing geographic gaps and delivering high-quality neurological care. Through a case study, attendees learn about models of virtual care and how scaling these models improves care for Veterans in rural America.

The Improving Rural Enrollment, Access, and Healthcare in Rural Veterans program enhances healthcare access for veterans across Michigan's rural Upper Peninsula and northeastern Lower Peninsula and northern Wisconsin. Funded by the Federal Office of Rural Health Policy, the program helps veterans enroll in healthcare, resolve technology and transportation barriers, and connect with local resources. I-REACH also supports rural providers by strengthening coordination with Department of Veterans Affairs Community Care Network and advancing community-based suicide prevention.

**Belonging and Rural Practice Intent in Youth Pathway Programs**

Rural communities face persistent healthcare workforce shortages that limit access to quality care. This session shares findings from a qualitative case study of a high school Medical Sciences Club in rural Northern California, highlighting how belonging, identity development, and place-connection influence students' interest in healthcare and intent to practice locally. Participants will learn how place-based, equity-centered educational programs can strengthen rural workforce pipelines and support "grow our own" strategies that prepare future rural healthcare providers.

## **Enhancing Rural Health Access through Student-Run Clinics**

The Rural Outreach Clinic (ROC) is a student-run, interprofessional organization through the University of Nevada, Reno School of Medicine that provides free primary care, preventive services, and health education to uninsured and underserved residents in rural Nevada. This session explores the discrepancies between urban and rural Nevadans, achievements of the ROC, the integration of Community Health Workers into clinic operations, and address disparities in health literacy between Spanish- and English-speaking patients in rural communities.

## **4B. Enhancing Reproductive Survivorship Care in Rural-Border Communities**

Adolescent and young adult cancer survivors face complex reproductive health risks that are poorly addressed in current survivorship care plans, particularly for those with low health literacy or limited English proficiency. This mixed-methods study designed and pilot-tested a bilingual, web-based reproductive health survivorship care plan tailored for a rural U.S.–Mexico border region. The intervention demonstrated high acceptability and feasibility for integration of reproductive health information into survivorship care for culturally and linguistically diverse populations.

## **Addressing Postpartum Hypertension with Remote Patient Monitoring**

MaineHealth's Obstetric Blood Pressure Remote Monitoring Program is a six-week postpartum initiative where patients submit daily blood pressure readings through an online portal. Local care teams, supported by centralized staff, monitor results, adjust medications, and provide

timely interventions. The program operates in rural hospitals, replacing in-person visits that often require hours of travel. By reducing barriers to access, it ensures patients receive appropriate care at the right time, improving safety and convenience during postpartum recovery.
